

RESOLUTION 2023-06:

A RESOLUTION SETTING UPDATED WATER RATES AND FEES

WHEREAS, the Nehalem City Code Chapter 51 provides authority for the City of Nehalem to set water rates by resolution; and

WHEREAS, the City adopted Resolution 2022-05, adjusting monthly base rates in July 2022, and the City wishes to wait until a twelve-month review of the adjusted rates has been completed before considering another adjustment to monthly base rates; and

WHEREAS, prudent use of the City's financial resource requires that the City charge fees sufficient to recover the cost in personnel time and materials for the installation of water meters and utility billing services.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NEHALEM:

Section 1. The rates, charges and fees established for the City of Nehalem water system are adopted as follows:
